To Merge or not to Merge?

That is the question now facing the Woodland and Davis AAUW branches. For the past few months, discussions about the challenges facing AAUW Woodland getting members to step up to fill officer positions for the upcoming year have been taking place. On February 11th, Barbara Durst, co-president of AAUW Woodland, forwarded the AAUW Woodland branch newsletter which included the following information.

"Please step up or Woodland AAUW may be stepping down. We have spoken to members of the AAUW Davis Board and we have contacted the California Branch Committee to explore the requirements and mechanics of a merger and that will be part of the discussion on March 10 if we cannot find members to seat a new board for 2023-24. We may also discuss disbanding Woodland AAUW."

Well, that was pretty clear writing on the wall. But how can that be after all their incredible fundraisers, their scholarships for Woodland Community College students, and their commitment to sending four girls to Tech Trek Camp at Sonoma State University every summer?

Soon after their March 10th board meeting, Barbara called me to discuss her concerns about the viability of the Woodland AAUW branch continuing. The fact is that they have 19 members and very few are active. Currently Barbara, Juliana, and Carolyn serve as co-presidents and after many years of dedicated service they are ready to turn the reins over to others. Their current long time Tech Trek coordinator is looking for a replacement as is the long serving Treasurer.

Since AAUW Woodland had yet to have anyone step up to fill executive positions their board contacted AAUW California for information and guidance on how to merge with AAUW Davis. Over the past few weeks they have gone through various drafts of Memorandums of Understanding outlining the steps for a merger with AAUW Davis and are hoping that we are willing to welcome them into the Davis branch. In the MOU it is suggested that a name change for the merged branches be open with the idea to be inclusive to communities in both Yolo and Solano counties, especially given that AAUW Davis has active members in Winters, Vacaville, and Fairfield. A name change of AAUW Yolano has been suggested as a possibility.

The AAUW Davis Board is in the early stages of considering the possible merger of our two branches. We would very much welcome the historical perspectives on this merger from long time AAUW members, as once upon a time we were one branch. I personally would like to know the entire history of AAUW in our area. Is there someone who has this information?

UNA Update Verena Borton

One of UNA-USA's signature annual events, the Leadership Summit, will be held in Washington, DC from June 4-6, back in-person for the first time since 2019 limited to around 250 members. For those of us who cannot travel to DC for this three-day immersion in education, inspiration and mobilization the event is available virtually June 4-5. The in-person attendees will be able to advocate with our congressional representatives on the Hill on June 6.



Advocate for what? Central to UNA-USA's advocacy effort in support of a constructive relationship between the U.S. and the UN is pleading for full funding in FY2024 for the UN's agencies, programs and UN peacekeeping. This is the time when the U.S. budget is hotly debated, negotiated and decided. All 193 members of the UN are required to make payments to certain parts of the organization as a condition of membership. The amount each member state has to pay, known as its assessed contribution, varies widely and is determined by a complex formula that factors in gross national income and population. These mandatory contributions help fund the UN's regular budget, covering administrative costs and a few programs (critical among them the International Atomic Energy Agency and the World Health Organization), as well as peacekeeping operations. There are currently twelve peacekeeping operations deployed across Africa, the Middle East, Asia and Europe, with essentially no U.S. "boots on the ground."

In 2023, the UN assessed the United States' share of the regular budget at 22% and its share of the peacekeeping budget at 27%. Unfortunately, Congress caps contributions to the peacekeeping budget at 25%, regularly leaving the U.S. in arrears (and other nations' peacekeepers potentially unpaid). China and Japan, the next two largest economies by GDP, pay the second and third largest assessed contributions.

UN members also make voluntary contributions. Many UN organizations, among them the United Nations Children's Fund (UNICEF), the Office of the UN High Commissioner for Refugees (UNHCR) and the World Food Program (WFP) rely mainly on voluntary contributions. While the U.S. is the largest contributor to the UN (\$12.5 billion in 2021 – one quarter assessed and the rest voluntary), the amazing fact is that all these contributions total just 0.2% of the federal budget. Advocates like to refer to this as "a lot of bang for the buck." This represents about a quarter of the roughly \$50 billion the U.S. spends annually on foreign aid. By comparison, that contribution is about what the government allocates annually to the U.S. Coast Guard.

UNA Update Cont.

Food for thought:

- At present some 339 million people are estimated to need humanitarian aid
- Roughly 103 million people are currently displaced, the highest ever recorded according to UNHCR
- Today at least 222 million people are food insecure including some 45 million people facing starvation in what the UN calls "the largest global food crisis in modern history."
- Vaccinations could determine whether a child lives or dies. COVID-19 decreased vaccination rates to a level not seen in more than a generation. Because of the pandemic, there are millions more children who are completely unprotected against dangerous, often deadly, diseases. In April WHO launched "The Big Catch-Up": a global push to make up for the pandemic losses in order for every child to get the vaccines they need, as well as to strengthen local health systems to integrate immunizations into primary health care.
- There are now more than 8 billion of us on planet Earth. Half of that population is under 30, and 10 billion people will be born before the year 2100.

Defending Equality: Title IX and the Equal Rights Amendment - AAUW Washington Update *Meghan Kissell, Senior Director of Policy and Member Advocacy*

We are still early in the 118th Congress and it has already been an eventful few months demonstrating why AAUW continues to fight for strong policies to advance women's equity and education. There are ongoing attacks on access to reproductive health, transgender youth, and even a failed U.S. Senate vote on the Equal Rights Amendment (ERA)!

However, there is also so much to be excited about. Last month, AAUW announced that we are awarding \$6.3 million in fellowships and grants to 285 exceptional awardees, continuing our commitment as one of the largest funders of women's graduate education. We will also bring together hundreds of college women from around the country for leadership, advocacy training and networking for our <u>National Conference for College Women Student Leaders (NCCWSL)</u> in just a few weeks. And we are working with Congress to support women's economic empowerment and continuing the fight for ERA.

As AAUW's new policy director, I look forward to working alongside you in support of women's equity!

Act — Take action on the most pressing policies

Last week, Julie Su's nomination to be the next U.S. Secretary of Labor advanced out of the Senate Health, Education, Labor, and Pensions (HELP) Committee. AAUW supported Ms. Su's previous confirmation as the Deputy Secretary of Labor in 2021, and <u>believes she is the best choice for</u> <u>the position of U.S. Secretary of Labor to achieve an inclusive economy.</u> Julie Su represents the best of America.

Ms. Su spent decades of her career advancing gender equity and economic security for women and families. She has achieved significant expansions on state gender pay equity laws, paid sick leave protections, labor rights for childcare and farm workers, and workplace sexual harassment and violence prevention. As the country works towards economic recovery, Ms. Su will work to ensure that this brighter future includes everyone.

Learn — Dig deeper into the issues that matter

For more than 50 years, Title IX has prohibited sex discrimination in education, covering both staff and students in any educational institution or program that receives federal funds. The Biden-Harris Administration has worked on two sets of proposed rule changes to Title IX. In June 2022, the U.S. Department of Education proposed rules to restore students' protections against sexual harassment, affirm protections for LBGTQ+ students, strengthen supports for pregnant and parenting students. AAUW provided <u>public comment</u> in support of these changes and recently called on the Administration to finalize the rules before the end of this school year.

In April, the U.S. Department of Education proposed a separate Title IX rule affirming the rights of all students, including transgender, nonbinary, and intersex students, to participate fully and equally in school sports without discriminatory rules. The rule would prohibit schools from categorically banning transgender students from participating in sports consistent with their gender identity. If properly implemented and applied, it would mean that the 21 states with blanket bans prohibiting transgender students from playing on sports consistent with their gender identity would be in violation of Title IX. AAUW is working with partners to <u>submit</u> <u>comments to strengthen the proposed rule.</u> Comments are open until May 15.

In April, the U.S. House of Representatives passed a <u>bill</u> intended to ban transgender women and girls in school sports. While the bill is unlikely to pass the Senate, President Biden stated he would veto any such bill if it should pass Congress. These attacks on transgender rights are thinly veiled efforts to undermine and erode civil rights protections.

AAUW has supported Title IX since its passage nearly 50 years ago, and we continue to fight against gender-based discrimination on behalf of all people today. To learn more, check out our 2022 webinar with GLSEN and the Women's Law Project on <u>Title IX and transgender student rights.</u>

Engage — Share the important work we're doing

- Last week, the U.S. Senate voted to remove the arbitrary deadline for ratification of the Equal Rights Amendment (S.J. Res. 4/H.J. Res. 25) as the 28th Amendment to the U.S. Constitution. Due to the nature of this vote, it would have required a two-thirds majority to pass. While the vote failed to meet the 60-vote threshold to pass, Senate Majority Leader Schumer entered a vote to reconsider so the issue can be voted on again later this session. Help keep up momentum by signing this <u>nationwide petition</u> in support of the Equal Rights Amendment.
- Members of the House and Senate will be back in their districts during this month's congressional work periods—a great opportunity to build relationships with your legislators and cultivate your influence on the issues that matter most to you. Watch the latest webinar with the AAUW Public Policy Committee and Lobby Corps on <u>How to Engage with Elected</u>
 <u>Officials</u> and use AAUW's <u>Resource Guide</u> to inform your advocacy.
- As we celebrate Mother's Day, AAUW continues to advocate for critical supports for working mothers and families including child care, paid family and medical leave, and paid sick days. On April 18, President Biden signed an <u>executive order</u> directing federal agencies to make childcare more accessible and affordable and to enhance job quality for early care workers and educators supported through federal grant programs.
- Access to a full range of reproductive health services, including abortion care, enhances an individual's reproductive choices—which leads to improvements in women's health care and economic security. Earlier this year, the U.S. Food and Drug Administration was <u>sued</u> over its approval of mifepristone, a safe, effective medication commonly used in medication abortions. On April 21, the Supreme Court granted a stay allowing mifepristone to remain on the market as the case continues to move through the Fifth Circuit and Supreme Court.
- May is Older Americans Month. Older workers face particular forms of discrimination that limit their ability to earn a paycheck, and women are more vulnerable than men as they reach retirement due to a lifelong pay gap. On March 29, the AAUW-supported Protecting Older Workers Against Discrimination Act (S.1030) was reintroduced, which would give older workers the tools to battle age discrimination and continue to take home a fair wage.

MAY GRAY IS WELL ON ITS WAY BUT JUNE WON'T BE GLOOMY FOR TECH TREK!

We made it through all kinds of weather and currently have nearly 800 campers registered in nine residential and virtual camps across the state and another 160 or so alternates waiting in the wings to attend!
